Affordable Care Act - Open Enrollment

Open enrollment for healthcare plans purchased on the healthcare marketplace began November 15th. All marketplace plans expire on December 31st, 2014 regardless of when they were purchased.

To get coverage beginning on January 1st, 2015, consumers must enroll no later than December 15th, 2014. Consumers who enroll by January 15th will have coverage effective February 1st, and those who enroll by February 15th will have coverage on March 1st.

Individuals who do not re-enroll by December I 5th will automatically be re-enrolled in existing coverage. This re-enrollment will not consider new tax breaks and cost-sharing subsidies, so in order to take advantage of these possible cost savings and find out if new plans are available, it is important to complete the re-enrollment process.

The application this year is shorter, and designed to be easier to use.

The entire process has been streamlined and should be less difficult to navigate.

For assistance in choosing a healthcare plan, it is important that families compare different plans and evaluate what is important to them. There are many resources and tools available to help.

Children's Specialized Hospital has designed a health plan evaluation form that will help families compare different insurance plans and find out which one covers the services they need most. It can be downloaded from their website at www.childrens-specialized.org.

Insurance navigators and certified application counselors are also available to help. Go to <u>www.healthcare.gov</u> to find a navigator or counselor in your area. These individuals have undergone training to assist with enrollment, and can guide people through the entire process.

The Family to Family Health Information Center website <u>www.f2fmichigan.org</u> also has an entire section on the Affordable Care Act.

ACA Protections for CYSHCN

The Affordable Care Act includes protections for children and youth with special healthcare needs. Among the provisions that benefit CYSHCN are the following: you cannot be denied coverage due to a pre-existing condition; young adults may be able to stay on their parents policy to the age of 26 and in the case of a disabled adult child, sometimes longer; you can not lose coverage due to high-cost claims or the amount of services used; annual lifetime limits and caps have been eliminated; there are limits on out of pocket expenses; and all insurance companies must cover 10 essential health benefits. What are Essential Health Benefits?

The Affordable Care Act guarantees that all plans purchased on the healthcare marketplace contain 10 **Essential Health Benefits (EHBs).** This means that all insurance plans have to offer a baseline level of care and include these services. These 10 benefits must be offered without any annual or lifetime limits; however, insurance companies are allowed to choose the duration, level and scope of the service offered.

Preventive services must be offered at no cost to the consumer, which means you can not be charged a co-pay or have to apply the amount towards your deductible.

The following is a list of the 10 EHBs

- Outpatient physician visits
- Emergency services
- Hospitalization
- Maternity and newborn care
- Mental health and substance abuse treatment
- Prescription drugs
- Rehabilitative and habilitative services
- Laboratory services
- Preventive services
- Pediatric services, including vision and dental

Habilitative vs. Rehabilitative Services

Many families with children with special healthcare needs have had difficulty obtaining therapies for their children in the past. Insurance companies often denied coverage for physical therapy (PT), occupational therapy (OT) and speech on the basis that they were "educational" or "developmental" and not medical.

These services are **habilitative**, which means they are services that "help a person keep, learn, or improve skills for daily living." An example of a habilitative service is speech therapy for a child who has never spoken.

A **rehabilitative** service is one that "helps a person get back or improve skills and functioning for daily living that have been lost of impaired because a person was sick, hurt or disabled."

Both services must now be offered in plans purchased on the Healthcare Marketplace, but insurers are allowed to substitute one for the other. Consumers should check what is covered and compare plans if this is an important benefit to your child.

Caregiver's Corner

The holidays can be a stressful time of year for everyone, but particularly for families with children with special healthcare needs. Every child is different and what works for one family may not work for another, but here are a few tips:

Be flexible: Figure out what works best for your family. This may mean giving up some old traditions and/or starting new ones. That's ok. The happiness and comfort of your children should be most important.

Manage expectations: This applies to you as well as your children. Let them know what to expect when things will be different. For you, remind yourself that the holiday doesn't have to resemble a Norman Rockwell painting to be meaningful.

Most of all, keep a sense of humor and perspective. Try not to stress the small things!

Insurance Coverage for Autism

Tips for Transition

What happens when my pediatrician won't see me anymore?

One of the most difficult parts of transitioning to adult care is leaving a trusted pediatrician who you may have been seeing for years, maybe even your whole life!

How do you find a new doctor? A good place to start is with your current doctor. See if he/she can recommend someone to you. Ask your family and friends. If you have friends with similar health concerns or issues as you, they may be a good resource.

Your insurance plan should have a provider directory. Look for someone who is accepting new patients, and find out where the office is located. Make sure it is an office that will be easily accessible to you.

It can be helpful to call the office ahead of time and ask if the doctor has experience in treating patients with health concerns similar to yours.

Lastly, when you meet a new doctor for the first time, ask questions. Make sure you feel comfortable. You need to find someone who will be a good fit for you.

Is your family up to date on vaccinations?

In addition to recommending that everyone get a flu vaccination every year, the Michigan Department of Community Health (MDCH) advises that getting vaccines and staying healthy is a lifelong job. You never outgrow the need for vaccines. In addition to following a schedule for infants and small children, more vaccines have become available for pre-teens and adolescents. Vaccines for adults depend on a variety of factors, including age, lifestyle, highrisk conditions, type and locations of travel and previous immunizations. The MDCH has information for the public on its website regarding the vaccines your family needs to stay healthy, as well as a link to the Michigan Care Improvement Registry, which contains the immunization records of Michigan residents. The MDCH website also contains a link to the Alliance for Immunization in Michigan (AIM) where you can find all kinds of information about vaccines and why you should get them, including side affects and risks. Public health officials advise us that vaccinepreventable diseases can be serious



and even deadly. The benefits of getting vaccinated far outweigh any risks. The AIM website also contains information regarding the relationship between vaccinations and autism, and the HPV vaccine.
